Discussion followed. Discussion followed. Motion by Alderperson Eric Hohol, the motion seconded by Citizen Member David Erdman, to approve the request from the Stoughton Garden Center located at 1471 USH 51 West to participate in the WPPI Energy/Stoughton Utilities shared savings program consisting of the installation of 52 exterior fixtures of LED lighting upgraded fixtures at a cost of \$8,299 minus a \$901 Focus on Energy rebate yielding an advance payment of \$7,396. Stoughton Utilities Employee Status: Stoughton Utilities Director Robert Kardasz presented and discussed Stoughton Utilities employee status, emphasizing that eight employees, or 33% of the workforce have left since 2010, compensation was a contributing factor to seven of eight, and the continued support of the Stoughton Utilities Committee and the Stoughton Common Council to move market employee compensation in three annual steps culminating in 2015 will improve recruitment and retention. Discussion followed.
