Stoughton Utilities Participation In The Madison Metropolitan Sewerage District (MMSD) Adaptive Management Program: Stoughton Utilities Director Robert Kardasz presented and discussed the Stoughton Utilities participation in the MMSD Adaptive Management Program. Discussion followed. Motion by Alderperson Michael Engelberger, the motion seconded by Citizen Member Alan Staats, to approve the submittal of the "Preliminary Adaptive Management Request" form to the Wisconsin Department of Natural Resources and recommend it to the Stoughton Common Council for approval and adoption of the corresponding resolution on January 26, 2016. <u>Stoughton Utilities Round-Up Program:</u> Stoughton Utilities Director Robert Kardasz presented and discussed the Stoughton Utilities Round-Up Program. Discussion followed. Motion by Citizen Member John Kallas, the motion seconded by Alderperson Michael Engelberger, to donate \$1,000 to the River Bluff Middle School 7<sup>th</sup> grade students for participation in the "Trees For Tomorrow" natural resources specialty school. The motion carried unanimously 6 to 0.

Modifications To The Stoughton Utilities Wastewater And Water Capital Improvements Plans: Stoughton Utilities Director Robert Kardasz presented and discussed the modifications to the CIP's as follows:

Sanitary sewer main (\$126,000) and water main (\$295,000) on Clyde St. from Van Buren St. to Madison St. and limited sanitary sewer main and full water main (\$165,000) on Van Buren St. from Clyde St. to Harding St. \*

Defer sanitary sewer main (\$105,000) and water main (\$110,000) on Park Street from Lynn to Academy to a future year to be determined. \*

Sanitary sewer main (\$250,000) and water main (\$280,000) on Van Buren St. from Jackson St. to Main St.

Abandon redundant water main and one water service (\$7,000) on Jackson St. between Van Buren St. and Harrison St.

\*Previously included in our 2016 CIP.
